Public Announcement -Sewer Use Appeals Committee Decision As Chair of the Sewer Use Appeals Committee, Councillor Taggart read into the minutes the following public announcement:

"The Sewer Use Appeals Committee for the Municipality of Colchester unanimously decided to overturn the March 2013 decision of the Director of Public Works to allow the discharge of 4.5 million litres of hydraulic fracturing (fracking) wastewater into the sewer systems of Colchester County. This decision is made pursuant to s.20.1 of the Sewer Use Bylaw after a careful review of all available evidence and having invited public comment from all interested parties by way of a public appeal process. The Committee feels that there is insufficient information to satisfy itself that the ingredients in the fracking wastewater and methods used in the fracturing process pose no health, safety or environmental hazard. Neither is it satisfied the fracking wastewater would not interfere with the operation of its wastewater system."

A copy of this public announcement was circulated to Council and members of the media present at this meeting.

Street Paving of J-Class Streets Under Provincial Cost-Shared Paving Program Moved by Councillor MacKenzie Seconded by Councillor Gibbs

paving project of all three streets, of which \$57,560 plus excess costs to a limit of 10% above the estimated value, to be paid by the Municipality as

an unbudgeted item from general operations."

INFORMATION ITEMS

Dieppe Avenue Widening

On March 26, 2013, Mr. Len Reilly made a presentation to Council regarding the widening of Dieppe Avenue in Debert and safety concerns relating to the current parking practices. He also delivered a petition to Council with 47 signatures requesting a 0.6 metre (2 feet) widening of the street. Key concerns from residents were ability to access street when cards are parked on both sides, safety for children, and road surface condition.

A staff review of these issues resulted in the following:

- widening of the street not sufficient to allow for two parked cars plus a clear passage in between.
- widening of the street would have a detrimental effect on current driveways and in many cases, would reduce driveway parking spaces from two to one.
- widening of the street would result in increased travel speeds which is undesirable when safety of children is a concern
- paving or upgrading street not required under municipal policy for another three to four years.

Staff will install "no parking" signs along the east side of Dieppe Avenue at a cost of \$2,000.

Status Update -Debert

On January 9, 2013, staff forwarded a letter to Communities Culture and Heritage regarding the exhaustive nature of archaeological testing for Debert. Questions were asked of the Province and recommendations for changes to the process were made. To date, the Province has not

responded with any feedback. It has been reported that a response has been drafted but was being reviewed by all affected departments. Until such time as that is received, all archaeological work in Debert is on hold.

During discussion on this item, Mayor Taylor agreed to raise again with the Premier the lack of response from the Province. Staff agreed to come back to Council at some point with an Action Item clarifying whether CPDS properties were excluded from archaeological investigation. Councillor MacInnes indicated that he would like to be more involved in discussions regarding Debert.

Granville Drive Sewer Extension - Status Update

Subsequent to Council's approval of \$175,000 in 2012-13 for the design of the Granville Drive sewer system, staff conducted a competitive bidding process for the design services. The work was subsequently awarded to C.J. MacLellan and Associates. The topographic survey for the design has been completed and a draft preliminary report has been submitted to staff for review. Once the preliminary design report is finalized, the contractor will begin the detailed design work which has an anticipated duration of six weeks. Staff will be presenting construction cost estimates to Council during upcoming capital budget deliberations in June.

Garbage Disposal -Rural Areas

Knowing that staff will be looking at illegal dumping, Councillor Stewart reported five areas in his district where this issue has become a problem. Other Councillors reported similar situations in their districts.

Noise Complaints

Councillor Stewart indicated that a couple of people in his area with noise complaints were told by the RCMP that nothing could be done without a County by-law in place. As Chair of the Police Advisory Board, Councillor Blair offered to look at minutes of past meetings where this issue was discussed and email information to Councillor Stewart.
