Second Reading – Chapter 57 – Construction and Demolition Disposal By-law AND Chapter 58 – Disposal of Hazardous Substances By-law

Mayor Blair welcomed everyone in the gallery to tonight's meeting. A brief background on this item was given and Mr. Dennis James, Municipal Solicitor, reminded Council that slight edits to both policies were made since First Reading.

Discussion was held on the definition of Hazardous Substance and whether the by-law left room for this definition to be broadened in the future if needed.

"That Section 2.5 in the Construction and Demolition Disposal By-law and Section 2.4 in the Disposal of Hazardous Substances By-law be amended to include the words "or policy".
