Further discussion was held on support if projects being done are for the greater good; concerns about the type of projects being approved; receiving reports on projects approved and amounts paid by property owners; and delays in carrying out work due to provincial regulations.

Ms. Newell advised that there is a Small Flood Policy which the Committee follows for flood mitigation work. Council has opportunity to review and make policy revisions should they wish to do so.

Council indicated that there are a number of groups already carrying out clean-up projects throughout the County that do not get paid. Some members of Council indicated safety and liability were key concerns.
